KoleCt Member App



KoLeCt is an electronic app available on either IOS or Android devices which will allow the farmer to book a collection of their fallen stock in 24/7.

The system allows farmers to capture tag information, which gets printed both on the electronic receipt and the monthly invoice. Receipts are generated automatically and emailed immediately once the driver has collected the animal. Farmers can trace the status of the collection in real time via the app and details of all their collections will be available to them for 90 days.

Following the successful roll out of our member application KoLeCt continues to rise in the North of England and Scotland, where both collectors and members have reported favourably on the benefits to them. NFSCo will be hoping to expand the availability to other areas in the very near future.

NFSCo is committed to using IT solutions to make life easier for it`s members and collectors at the same time doing it`s bit for the environment in saving in the use of paper.



The last year in NFSCo has been one of highs and lows. The development and roll out of the KoLeCt system, with paperless, online records and now the farmer app, has seen the streamlining of our offering to farmers and the continued development of our aim, to ensure fair and competitive pricing. This has engaged us as a company for almost two years in developing, testing, piloting and the roll out. For a small team of five people plus our IT support this has been a mammoth task and one that I am proud to say is working brilliantly.

Then we have the low, the loss of Ian Potter from both his company's point of view and the wider industry has robbed us prematurely of someone who, whilst challenging, was an individual who felt passionately about our industry widely, the dairy sector specifically and was never afraid to challenge anybody who he believed was standing in the way of progress.
